


STATE OF PLAY

10 Large Infrastructure Projects, 65 regular projects and 5 micro-projects were contracted so far. All these projects are in the implementation phase, 2 of them have already submitted their interim reports.

The Programme bodies have taken several important steps to assist the beneficiaries in both contracting and reporting (for details on the activities supporting beneficiaries please see map on page 8-9). Belarusian and Ukrainian beneficiaries may now select auditors for the expenditures verifications as both lists of auditors are set up and published on the Programme website. Also, *General rules of procurement by beneficiaries within the PBU projects* have been introduced to set up clear rules for organizing procurements.



The 2nd Call for Proposals was conducted in August-October 2018, and its results approved during the 5th Joint Monitoring Committee meeting. The first two micro-projects selected in the 2nd Call have been signed already. Two successful applicants resigned from signing the contract. It is expected that all remaining 70 micro-projects will be contracted by the end of October 2019.



Since not the whole allocation for the 2nd Call was consumed, it was decided to organize the 3rd Call for Proposals. It is to be launched in the fourth quarter of 2019, focusing on micro-projects within Thematic Objective HERI-TAGE. On 28 June the Managing Authority submitted Final Report for the 2007-2013 Programme to the European Commission. The Programme absorption rate equals almost 88%.



SECOND CALL FOR PROPOSALS

Although memories of busy summer 2018, when the 2nd Call for Proposals was launched, are still fresh, we are now able to share the results of the micro-projects' selection process. Let's recall what was happening during last months.

Getting ready with the applications

2nd Call for Proposals was dedicated to the Thematic Objective HERITAGE. The issue of heritage is highly relevant for the Polish-Ukrainian-Belarusian borderland, which is rich in cultural and historical landmarks, unique intangible culture and important natural sites. There is still much to be done for better preservation and promotion of local heritage in this area and joint efforts of cross-border partners can be the best solution. The 2nd Call for Proposals was open for projects with small budgets (grants ranging from **20 000** to **60 000 EUR**), focusing mainly on non-investment activities promoting cooperation, building of new cross-border citizens' contacts and relations, exchange of experiences and social initiatives in connection with culture and history.

The launch of the Call was preceded by months of hard work. The Joint Technical Secretariat (JTS) team did its best to facilitate the processes of project preparation, submission and assessment. Several important changes and simplifications were introduced such as shorter and simpler Application Form (without concept note phase), lack of annexes at the application stage, more simplified costs options introduced. The Call was open also for institutions without previous experience in implementation of EU projects.


In total 36 events were organized to assist the applicants on project design stage. To start with, all potential beneficiaries had an opportunity to establish contacts with the institutions from across the border during two Partner Search Forums, which were held in Lublin and Brest. In addition, partner search was enabled through online facility on the Programme webpage. From 11th till 28th September, a series of trainings was held in all Programme regions. All those who joined those events had an opportunity to learn about main assumptions of the 2nd Call for Proposals, recommendations on how to develop a high-quality project proposal using the e-generator. In total, 1090 people attended the trainings in 3 countries. The trainings were followed by individual consultations with JTS project managers, during which the applicants had an opportunity to discuss their project ideas.

Evaluation - a hard choice to make

Before the deadline 31 October 2018, 250 applications were submitted to the JTS office, including 198 applications within *Promotion of local culture and history* and 52 within *Promotion and preservation of natural heritage*. The total value of submitted projects amounted to over 15.3 M EUR while the total value of requested EU co-financing was 13.5 M EUR. More than 460 organisations from all three countries demonstrated their willingness to implement their projects. Interestingly, 75% of them submitted their documents for the first time in our Programme.

JTS experts were busy evaluating Application Forms from November 2018 till February 2019. In order to speed up the whole assessment process, all its phases: administrative, eligibility and quality checks were performed simultaneously. The results were discussed by the Project Selection Committee during its meeting held on 26th March in Warsaw. The list of selected projects was approved by the Joint Monitoring Committee (JMC) on 17th April 2019 in Niasviž, Belarus. The JMC decided to co-finance 74 projects out of 250 submitted applications. The total amount of awarded EU co-financing equals to **4.14 M EUR**. 178 beneficiaries got the opportunity to implement their ideas one-third of them being NGOs.

All Programme regions are represented on the list of selected projects and all 14 regions will benefit from our Programme through numerous interesting initiatives targeted, in particular, at preservation of historical buildings, wooden churches, research of the common history and prominent people, promotion of local crafts such as embroidery and pottery, traditional cuisine, folklore (songs, traditions) etc. Also, many vital projects in the area of natural heritage protection and promotion are on the winner's list including




preservation of rivers and lakes, rare animal species, sustainable tourism development. All these projects will contribute to the development of our cross-border areas, making them more attractive both for their inhabitants and visitors. We congratulate the winners and wish them good luck in implementation of projects.


PROJECTS SELECTED FOR FINANCING

The eligibility of beneficiaries in all selected projects was already proved. The JTS expects to finish contracting of micro-projects till the end of **October 2019**. In the fourth quarter of 2019, the Programme will offer more opportunities for the applicants by announcing a the **3rd Call for Proposals** dedicated also to HERITAGE and micro-projects.

REGULAR PROJECTS - FOCUS ON SECURITY

It is a universal truth that human life and health are priceless. Ensuring people's safety and improving their health and well-being are acknowledged as top priorities on a global level. Aren't we all striving for a longer and healthier life free from dangers?

Our Programme is contributing to increased safety and security in the cross-border areas. Security was chosen as one of its Thematic Objectives considering the need for a common response to the threats, which have no borders, such as diseases, emergencies, crimes, social tension etc. The number of concept notes received within this priority (248) testifies to the fact, that local players recognize safety and security as serious problems pertaining to the areas and, which is even more important, can offer solutions to them.

All the 23 projects implemented within the Programme under the objective of Security reflect the needs of the areas. They include actions in the field of healthcare, social services and emergency situations. There are 14 projects within the priority 3.1 Support to the development of health protection and social services and 9 projects within the priority 3.2 Addressing common security challenges.

What's behind these figures? What's happening in our projects and how the noble goal of increasing security on the borderland is achieved? We invite you to learn more about our selected projects.









Stay safe in the mountains!

The Eastern Carpathians, which cover the Southern part of our Programme area, is an exceptional area. Fresh mountain air, breathtaking views, unique natural values, living history and traditions are just a few reasons to spend a hiking holiday here. Although this part of the Carpathians called Bieszczady in Poland and Beskydy in Ukraine, is considered relatively tourist-friendly and safe unfortunately it is not free from different kinds of hazards.

The reason for the accidents among the hikers is that they are not prepared for adverse weather conditions; are not aware of difficulties, do not know the route, are not equipped or dressed appropriately. Ski accidents are frequent, too... We designed our project with the view to have a team of trained volunteer rescuers on both sides of the border which would be able to react to accidents in the most efficient way. – says Mykhaylo Yavorivskyy, the Ukrainian coordinator of the project SOS - rescue - the training center for organizing and operating cross-border rescuing actions (SOSRESCUE).

The project activities will help to reduce waiting time and provide an effective response to emergencies. To this end, the premises will be adapted to the needs of modern rescue centres in Równia (Podkarpackie Voivodeship, Poland) and Slavsko (Lviv Oblast, Ukraine) professional equipment will be purchased, training courses for rescuers and volunteer fire-fighters organized. Moreover, public events will be held to raise awareness about safety in the mountains. The project will contribute to the general safety of local citizens and tourists in the area.

Safety in the mountains is also the topic of another PBU project **"Adaptation of former observatory on**

the Pip Ivan Mountain to the needs of alpine rescue service training centre" (PIMReC). The location of this project is so unique that we prepared a story about its past and today (*White elephant of the Carpathians*), which you can find on pp.14-15.

Is response to emergencies in the mountain areas same to that in the lowlands? Does it take the same time to stop a fire in a big city and a mountain village? It's definitely not the case in the Carpathians. Due to the mountainous landscape and poor condition of road infrastructure, especially on the Ukrainian side of the border, the disaster scene can be quite difficult to reach. Moreover, obsolete fire equipment may not be very helpful in saving people's lives and property.

The project "Joint protection of people and environment through the creation of Ukrainian-Polish system of disasters prevention and response in the Carpathians" (SECINCARP), is addressing this issue. It is unique because it joins the efforts of State Emergency Services of all three mountainous regions of Ukraine and Poland. To prevent and give an immediate response to the disasters four regional fire service units from Poland and Ukraine will cooperate. Vehicles (fire trucks and mini-buses), as well as refractory equipment sets, will be purchased. Also, a modern smoke chamber will be constructed in Przemyśl to conduct training sessions with the simulation of real emergencies. They will complement their joint actions and join efforts in practical trainings and tactical exercises in the 'close-to-real' conditions. The activities implemented under the project will contribute to shortening the response time to emergencies, which will affect the overall improvement of security in the region.

Polesie fire-fighters - training for the brave

As we move northwards, we discover more projects dealing with security issues. In picturesque Polesie, Polish and Ukrainian rescuers and fire-fighters are striving for a safer environment. Here, the quality of human capital – highly efficient rescues - is seen as a priority.

For instance, in Lublin Voivodeship and Volyn Oblast, where the cross-border area is characterised by high traffic and the poor road infrastructure, roadm safety is a key issue. Most accidents occur far from the cities where the emergency services and professional fire departments are located. The project "Strengthening the potential of the Volunteer Fire Department in rescuing victims of accidents on the roads of Lublin Voivodeship and Volyn Province" (PUFL) will improve road safety in the cross-border area by building the capacities of Volunteer Fire Departments in Poland and the newly created structures of local fire departments in Ukraine. These structures will not only receive first aid facilities and lifesaving equipment but also the rescuers will be trained to provide first aid to the injured in traffic accidents. This will help to shorten the waiting time for assistance and save people's lives. A "Safe pedestrian" campaign, targeted at children and adolescents, will bring added value to the project.

I am certain that our project will have a multiplying effect in Ukraine, where voluntary crews are only starting to emerge. Also, among additional effects of the project, which we didn't expect, the partnerships established between the local communities of Poland and Ukraine and they plan a joint projects. - comments Iryna Itani, the Director of Development Agency of Euroregion Bug.

Preparation of highly efficient fire-fighters and rescuers is a subject of another Polish-Ukrainian project, **"Effective coordination of rescue operation in the**



Ostroleka-Siedlce subregion and Volyn oblast" (Coordination) which will create modern training complexes in Lutsk and Siedlce.

I started working as an emergency officer after having five years of University but most people have no profile education and need to be trained. Today, even experienced fire-fighters need to enhance their skills as we are moving towards EU standards. Moreover, we have more and more volunteer fire-fighting units in the villages, where people don't have relevant skills. The training base with a smoke chamber fitted with simulators will be able to fill this gap and give a chance to train in close to real-life conditions and even test their physical abilities. Their health condition will be tested with the use of medical equipment. – said Dmytro Dubyna, who works in the Department of Emergency Service in Volyn Oblast.

Also, the creation of an equipment preparation base, a regional base of extinguishing agents, modernization of control station in Poland, purchase of 7 fire trucks and equipment will improve technical capacities of firefighting units on both sides of the border. It will ultimately lead to saving more lives and making Polesie a safer place to live.







Fast response to disasters on Poland-Belarus border

The emergency situations in border regions of Poland and Belarus requires emergency services to deal with specific risks and vulnerabilities such as ecological and chemical disasters.

It is the issue, tackled by the project "Shared initiatives for increasing security of the cross-border area in the event of ecological and chemical disasters" (EcoChem), and within its boundaries the landscape protection sites listed by UNESCO can be found. Industrial plants on both sides of the border, such as PERN Oil Base in Adamowo and many nitrogen production facilities in Hrodna region, are potential sources of danger. Within the EcoChem project, 9 rescue and fire-fighting vehicles for Volunteer Fire Departments in Siemiatycze District and 4 rescue vehicles for the Belarusian partner will be purchased.

The project "EcoChem" is of strategic importance. Only by working in close partnership we will be able to cope and prevent possible cross-border environmental and chemical disasters. We have one common border and common population, which we should protect in case of emergencies. We are always ready to help our neighbours. - says Sergey Khmara, the chief specialist of Hrodna Regional Department of the Ministry for emergencies of the Republic of Belarus.

Another project, strengthening the security of Hrodna Oblast and Podlaskie Voivodeship is **"The new approach** to the cross-border emergency management system" (CrossEMS). The project is a significant example of solving common cross-border challenges in the field of security. Many infrastructure investment and soft activities will be carried out. The construction works will be carried out on the fire station of Dobrzyniewo Duże (Podlaskie Voivodeship, Poland) and the newly-created fire station in the town of Sapockin (Hrodna Oblast, Belarus). The fire-fighting units will be provided with specialised equipment, such as heavy fire-fighting vehicles, rescue boat, a trailer for boat delivery, etc. The new equipment will improve the time of response to the emergencies. A key element of the project is an elaboration of the cross-border emergency management plan and network aiming at further strengthening of cooperation between the fire-fighting units of Poland and Belarus. Security is an important part of the prosperous and harmonic life of societies.

We are proud that thanks to our Programme local security initiatives had a chance of being implemented. We believe in hard-working and brave people, committed to their work, which helps to make our cross-border areas a safer place to live. And we are convinced that joint projects are the best way to address common security challenges in our regions. By today, many activities have already taken place in these projects. You can follow their progress on our Programme website and Facebook account and even participate in their public events in your region.

WHITE ELEPHANT OF THE CARPATHIANS

There is always a story behind each PBU project. Sometimes these are the stories of people whose lives had been strongly influenced by the projects. There are also the stories of people who brought these changes into their regions. In some cases, the places are the true heroes of our stories. Places, which can tell much about the turbulent history of cross-border land, connected with the destinies of people, who lived here. We have a pleasure to present the story about a very special place, which is now the venue of our security-related project.

When travelling in Ukrainian Carpathians, across Chornohora range, you will be surprised to see a large interestingly shaped building on the top of the mountain. This local landmark is the observatory of Pip Ivan Mountain, built in the 30th of the past century and neglected for more than 70 years. Its genius loci is continuously attracting travellers. It inspires artists and writers. A deserted observatory in the mountains is a key location of the novel "Twelve hoops" by Yuriy Andrukhovych. "Top down" a book of fears by Tanya Malarchuk and "White Elephant" by Mariya Rymar. "White Elephant" is a local name for the observatory because its building, covered with ice and snow resembles a giant animal. "White elephant" also means a valuable but useless thing.

In the first half of the 20th century, Pip Ivan was chosen as a location of an ambitious project of the Polish government (at that time it was the territory of the Second Polish Republic) - the astronomic observatory. The construction started in 1936 being a large and complex undertaking. In total, nearly 800 tons of construction materials had to be delivered from the railway station Vorokhta to the site on Pip Ivan (about 70 km). In two years, a building shaped as a mirror image of letter L, was erected on the top of the mountain. It was described as "monumental". The walls made from limestone blocks were 1.5 meters thick. The building had five floors, 43 rooms and 57 windows and was equipped with the use of most advanced technologies of these days. Astronomical and Meteorological Observatory named after Marshal Jozef Piłsudski was opened on July 29th, 1938. Władysław Midowicz, geographer and meteorologist, a native of Mykulychyn Village was appointed a director of the Observatory. He moved to the Observatory together with his wife and five-year-old son.

Unfortunately, the Observatory functioned for one year only. On 1st of September 1939 World War II broke out. On the 18th of September, all the staff had to leave the building. All valuable equipment and documents were removed or destroyed. Władysław Midowicz immigrated to Hungary, then he lived in Indonesia and Australia but he always had Observatory keys with him. On his death bed, he gave them to prof. Kreinery with the instructions to transfer them to the University of Warsaw. This is where they are kept, waiting for opening new doors to the rebuilt Observatory.

It was only in the 2000-s that the issue of Observatory revitalization was raised for discussion again. Center for the East European Studies at the University of Warsaw and Vasyl Stefanyk Precarpathian National University







generated a common vision of its future. Their idea was not only to reconstruct the building but to give it a new meaning – to serve for education and research purposes and contribute to people's safety in the mountains.

The idea found support in Ukrainian and Polish governments. Step by step the funds were secured and renovation works started. In particular, replacement of floors and roof framing. The roof was covered with brass plate. The stone fencing and gate appeared. Several rooms were adapted for temporary accommodation. Since 2017 a rescue station has been functioning here. Rescue workers of the 4th specialized search-and-rescue team of State Emergency Service in Ivano-Frankivsk Oblast permanently live here, working in shifts. In this way, Pip Ivan Observatory is now considered to be the highest inhabited place in Ukraine.

The project "Adaptation of former observatory on the Pip Ivan Mountain to the needs of alpine rescue service training centre" (PIMReC), funded within CBC Programme Poland-Belarus-Ukraine 2014-2020, is the next significant step in the revitalization of this unique place. The project was designed by Vasyl Stefanyk Precarpathian National University, the University of Warsaw, the Emergency Service in Ivano-Frankivsk Oblast and Mountain Volunteer Search and Rescue Bieszczady Group. The project will help to create a highly efficient 24/7 alpine rescue point and a training centre.

Along with being an important research facility, it will be one of the best alpine rescue schools, where the rescuers will be trained and the crews created to work in the observatory. – explains Igor Tsependa, the rector of Vasyl Stefanyk Precarpathian National University.

This aim will be achieved through the renovation of premises and their adaptation to the purposes of rescue point and a training facility. Also, Polish and Ukrainian mountain rescuers will participate in joint trainings with a focus on up-to-date rescue techniques in various weather conditions. The project team also plans to create a sustainable system of emergency response. To this end, the electronic services platform will be created to serve for the exchange of information and know-how between Polish and Ukrainian rescue teams at the same time helping tourists to ensure safe hiking in the mountains. The above mentioned activities will improve the professional level of high mountain rescuers and increase the awareness of safety issues in the cross-border community.

Jan Malicki, the Director of Center for Eastern European Studies, observes: When I visited the Observatory for the first time in 2007, only the most optimistic people could believe it would be renovated one day.

The Observatory means a lot to him, as well as to Igor Tsependa, as well as to many other people – scientists, researches, rescuers and volunteers. They are proud to contribute to its revival. They hope that their joint efforts will help to make this remarkable tourist attraction more accessible and safe, and that more people will be able to discover it.

2019JOINT MONITORING COMMITTEE

The 5th meeting of the Joint Monitoring Committee (JMC) took place in Niasviž Castle in Belarus. This castle has a symbolic meaning being an object of common historic heritage of Belarus and Poland.

The most important mission of the meeting was to decide on the results of the 2nd Call for Proposals. After a discussion, the JMC approved a list of 74 projects, selected for the co-financing (out of 250 submitted applications). Since the allocation foreseen for the 2nd Call was not used in full, the Joint Monitoring Committee decided to organize the 3rd Call for Proposals open for micro-projects within Thematic Objective HERITAGE.

In addition to this, JMC members discussed other issues in particular, implementation of large infrastructure projects and regular projects, the plans for the information and promotion activities in the Programme. Furthermore, it was decided to reallocate the funds from the Programme technical assistance budget to the Thematic Objective SECURITY to enable financing of the projects on the reserve list. Another important subject was a new Programme period 2021-2027.

25.06 2019 CHECKPOINT: HEALTH – THE ANNUAL PROGRAMME CONFERENCE IN HRODNA

This year, a beautiful historical city of Hrodna was a venue for the Annual Programme Conference, which was organized under the slogan Checkpoint: HEALTH - In pursuit of cross-border well-being. The Programme event gathered beneficiaries, representatives of the Programme institutions from Poland, Belarus and Ukraine and all those who support cross-border cooperation.

The Conference was focused on health issues and well-being, aiming not only to showcase health-related PBU projects, but to promote a healthy lifestyle in the cross-border area and discuss future actions in this field.

The representatives of the Managing Authority and Joint Technical Secretariat presented the Programme state of play and its implementation progress. Also, the first Grant Contract within the 2nd Call for Proposals was officially signed for implementation of the project "Cross-border heritage of the Białowieża Forest".

During the panel discussions, representatives of PBU healthcare-related projects shared their experience, best practices and spoke about the on-going and planned project activities. Besides, the ideas for future cooperation in the field of healthcare were discussed.





For us, the project is a window on the world; we come together and exchange experiences. We learn a lot from our friends from Ukraine, we learn from each other and that is the greatest value summarized common Polish-Ukrainian project one of the panelists - Paweł Natkowski, the Director of the dr Józef Psarski Mazovian Specialist Hospital in Ostrołęka.

To better promote not only our Programme, but also healthy attitudes among Hrodna citizens, the Conference was accompanied by the "Medical Town" where everyone had an opportunity to undergo free medical examinations or get consultations from doctors of the Hrodna City Clinical Hospital, one of our Programme beneficiaries. In total, almost 600 medical consultations were carried out, 300 blood tests, 67 fluorographic examinations and 62 electrocardiograms.

Representatives of the medical projects and institutions were eager to discuss their ideas for the new Programme period 2021-2027 during the "Medical Round Table". Their opinions and recommendations will be taken into consideration while preparing the new Programme edition.

Networking activities during the Conference were consistent with the general theme of the event. The participants engaged in sport activities - cycling and kayaking. The Conference ended up with open to the public concert of popular Belarusian band Uzari.

WRAINE «HERITAGE AND ME!» – THE FINAL EVENT OF EDUCATIONAL CAMPAIGN FOR SCHOOLS IN LVIV

On 20-23th September 2018, 24 school teams from Poland, Belarus and Ukraine came to Lviv to attend the final event within Educational Campaign for Schools. 96 children from the cross-border areas were looking forward to this meeting. This year's Campaign was devoted to the cultural heritage of the borderland.



During the event, the participants worked in the mixed cross-border teams, completing challenges related to the history and culture of the three countries, traditional arts and crafts.



The children also had an opportunity to work on joint projects, in the field of visual art, singing, dancing, fashion and museum work. They worked hard, guided by the professionals. The results were impressive!

After the official part, we took the Conference' participants to the open-air museum in Halych and the renovated monastery of Franciscans in Bilshivtsi, which was a valuable experience of touching the past of the area and a chance to learn about the ways heritage objects are treated.

10th ANNIVERSARY OF THE CENTER OF EUROPEAN PROJECTS

The Joint Technical Secretariat of the Programme is part of the Center of European Projects (CEP) – the institution responsible for the day-to-day management of 6 EU funded programmes.

The CEP was established in 2008 by the Minister of Regional Development and during the last 10 years, it has achieved impressive results. CEP units organized 75 calls for proposals, with over 1.3 billion euros to be distributed. The applicants' interest was usually three times higher considering the total amount of funding they sought for. The CEP has already contracted 900 projects, and 3000 partners have taken up cross-border and transnational cooperation. On the 12th December 2018 the Conference "Cross-border and transnational cooperation in the framework of EU Funds", devoted to the 10th anniversary of CEP, was held in Warsaw. It was a summary of CEP activities, sharing of its programmes' results and a discussion of future prospects.

The Center of European Projects is very much needed by the government to implement the strategy of responsible development and implementation of projects financed from European funds - assured Jerzy Kwieciński, Minister of Investment and Development speaking at the opening of the Conference.

STUDY VISIT OF UKRAINIAN LOCAL GOVERNMENT REPRESENTATIVES



30 representatives of Ukrainian local self-governments from cross-border regions took part in the study visit to Poland organized by our Programme in cooperation with the Carpathian Euroregion – Ukraine. The visit aimed at increasing capacities of Ukrainian officials, in particular, in the area of local development and implementation of EU-funded projects.

Kraków was the starting point of the visit, where the participants attended the 5th European Congress of Local Governments. In the next days they visited Podkarpackie Voivodeship, met Polish local authorities, discussed best practices in specific areas such as road infrastructure, protection of the environment, municipal management, culture, sports etc. They also had an opportunity to stopover at the locations where successful projects had been implemented, including Glass Heritage Center, Krosno Airport, Special Economic Zones "EURO - PARK" Mielec and Zagórz-Zasław, Waste Utilization Plant, Carmelites monastery ruins and the center of Polish-Ukrainian cooperation in Sanok District. For Ukrainian self-government officials, the tour was not only the way to learn more about the achievements and best practices of their Polish colleagues, but also a chance to establish contacts and discuss the ideas for future projects.



DERUNY, DRANIKI, PLACKI ZIEMNIACZANE...

What do you call potato pancakes at home? We found so many names for them!

In Ukraine they are known as деруни́ (deruny), терті пляцки (terti plyatsky) or тертюхи (tertyukhy) in Lviv Oblast, кремзлики (kremzlyky) in Zakarpatta but also терченики (terchenyky), тарчаники (tarchanyky), беці (betsi), картофляники (kartoflyanyky) - the list can be endless. And don't forget about latkes, prepared in Jewish families of Galicia! In Belarus, дранікі (draniki) and калдуны (kalduny) are national dishes. In Poland, placki ziemniaczane (placki kartoflane, bambrzaki, plendze, plindze or plyndze) are popular in all regions. It is believed that the dish came from German cuisine at the end of the 19th century. According to another version, the spread of potato pancakes and some other potato dishes began even earlier - in the second half of the 18th century. For the first time, the written recipe of potato pancakes is given in the cookbook of Jan Schittler in 1830.

Although basic ingredients such as grated raw potato, flour and eggs remain the same, we can find a great variety of ways to prepare potato pancakes. For instant, grated onion, which is usually added to potato mixture, can be combined with carrots, celery root, parsnip and

garlic. The grater with big or small holes is used, and sometimes even two types are combined to get a desirable crispy effect. In some cases, milk is added to the potatoes. Salt is an essential ingredient while spices and herbs are optional. Still, black pepper, cumin, marjoram, sage can be found in many recipes and will definitely enrich the taste. Grated potatoes are mixed with binders, like egg and flour (wheat or corn), although just potato alone can be used. When it comes to frying, any fat or oil will work. Lard, butter or sunflower oil are typical for these areas. Pancakes are cooked over medium-low heat until the bottom is golden brown and crispy. For Belarussian kalduny, a layer of meat farce is put on each pancake at the time of frying. Interestingly, there is a tradition of baking pancakes in the oven in Beskidy, Poland. When the pancakes are ready you need to answer another big question – how to serve them? Most people agree that potato pancakes go well with sour cream, mushroom sauce, meat goulash, cottage cheese or bryndza. In Poland, many would go for the sweet option with sugar, cream or marmalade.

Potato pancakes are loved in all three countries. They are often prepared and served during the festivals. Actually, there is even a Festival of potato pancakes, held annually in Korosten, Ukraine.
